### **Conditions of Entry: Entering this competition is conditional upon acceptance of these conditions**

1. Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
2. **Entry Fee** is \$75 per entry for Pony Club sections, \$85 for Open sections. Please note there will be no refunds after closing date 18/10/19 without valid medical/veterinary certificate. \$10 fee applies for all refunds and must be received within 7 days after the event.
3. **Before Riding - ALL Open Competitors** must complete and submit a **Liability Declaration form** available on the day. A \$15 **Day Participation Fee per day** is also payable in addition to the entry fee UNLESS proof of current financial membership of PCAV, EV/ EA, HRC AV. HRC AV Members riding above their grade are not covered by their insurance and need to fill out a **Day Participation Waiver** and pay the additional \$15 per day attendance fee.  
If you are required to pay the **Day Participation Fee**, you must also complete and submit a **Day Participation Waiver form**.
4. **Before Riding - All PCV Competitors** must present their 2018/19 and 2019/20 Grading Cards to office for inspection.
5. **Gear Check** for **ALL Competitors** is required 20 mins **before each phase**.
6. **Medical armbands** must be worn by All competitors in all phases.
7. **All Competitors** must wear “**Standards Approved**” **complying Helmets**. Complying Helmets are: AS/NZS 3838 (AU), ASTM F1163 (USA), PAS015 (UK), VGI (EUROPE), EN1384 (EUROPE) only up to and incl. 2015 (if made in 2016 not acceptable unless also complies with VGI) **Helmets may be spot checked and competitors with incorrect helmets incur elimination.**
8. **Competitor numbers** - the organising committee will pre-allocate and supply body numbers. Competitors must wear body numbers for **all phases**.
9. The organising committee reserves the right to cancel any section or competition; alter times; refuse any entry with or without stating the reason.
10. Competitors may ride more than one horse, subject to the conditions of PCAV *Handbook of By-laws* multiple horse rules.
11. All Pony Club Competitors must be graded by their DC for the Horse Trials grade they have entered.
12. Competitors under 8 years old may not compete in Pony Club Horse Trials.
13. Horses must be at least age four; no stallions, colts or rigs.
14. PCAV Alcohol Policy applies.
15. **Dogs are prohibited** at this event.
16. Queries, protests, horse abuse, rules as per the PCAV *Handbook of By-Laws*.
17. **No Lunging** permitted on the grounds.
18. Neither the organising committee of this competition, nor the PCAV, accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, Competitors, ground spectators or any other person or property.
