**CONDITIONS OF ENTRY:** Entry is conditional upon acceptance of these conditions.

1. Entering the clinic constitutes your acknowledgement that PCV rules apply and your acceptance of these rules.
2. Entry fee is per entry. Scratchings prior to closing date will incur a \$10 admin fee. No refunds after closing date except unless place can be filled. In the event the event is cancelled due to circumstances outside the club's control, the committee reserves the right to charge a \$10 administration fee on the refund of all entries.
3. Before Riding - ALL OPEN RIDERS must complete and submit a Liability Declaration form - available on the day. A \$15 Day Participant Fee is also payable in addition to the entry fee UNLESS proof of current financial membership of PCV, EV/EA, AHS, SHCA, AERA, HRC AV, an Interstate Pony Club or can provide proof of Personal Liability Cover of at least \$10,000,000. If you are required to pay the \$15 Day Participant Fee, you must also complete and submit a Day Participant Waiver form.
4. Before Riding - ALL PCV RIDERS must present their 2020/2021 and 2020/2021 membership cards to the event office for inspection. It is the rider's responsibility to present and accurate card on the day. PCV membership cards must prove eligibility and grading in accordance with the PCV Handbook.
5. Gear Check - all riders must present for gear check with the instructor prior to each phase.

6. All riders must wear "Standards Approved" complying Helmets. Spot checks may occur, and incorrect helmet will incur elimination. Complying helmets are AS/NZS 3838 (AU), ASTM F 1163 (USA), PAS 015 (UK), VG1 (Europe), EN 1384 (Europe) only up to and including 2015, (if made in 2016, is not acceptable unless it also complies with VG1).
  7. No horses under 4 years, no stallions, colts or rigs.
  8. All riders under 18 years must have a parent or allocated guardian on the grounds with them at all times.
  9. All efforts will be made to group riders according to grades but they may be mixed.
  10. All participants and parents are to abide by the Pony Club Code of Conduct Policy
  11. Ground Rules: Dogs are prohibited without exception, No lunging permitted, Due to the environmental sensitivity of the grounds, all feed, hay and manure must be removed and taken with you at the end of the clinic day.
  12. MPPC highly recommends back protectors are worn for Cross country
